

**TO APPROVE APPLICATION FOR THE FY25 TRIBAL MANAGEMENT GRANT (TMG) (Round 2)**

**IN THE TRIBAL COUNCIL OF THE CHOCTAW NATION**

**JAMES DRY INTRODUCED THE FOLLOWING COUNCIL BILL**

**A COUNCIL BILL**

**TO APPROVE** the application to the United States Department of Health and Human Services, Indian Health Service for the FY25 Tribal Management Grant (TMG) (FOA: HHS-2025-IHS-TMD-0002).

**WHEREAS**, the Choctaw Nation (the "Nation") recognizes the value of analysis, optimization, and streamlining of our health contracting process for our Choctaw Nation Health Services Authority in order to grow and enhance third-party revenue opportunities.

**WHEREAS**, the maximum federal budget is \$100,000.00 per budget period for 3 years for a maximum award of \$300,000.00 with no required tribal match;


**WHEREAS**, funds for TMG meets the Nation's strategic goals of supporting service delivery to improve quality of life of tribal members as well as achieving digital transformation through the adoption and implementation of systems, workflows, analytics and innovation.

**THEREFORE BE IT ENACTED** by the Tribal Council of the Choctaw Nation of Oklahoma that this Bill be cited as approval to apply to the United States Department of States Department of Health and Human Services, Indian Health Service for the FY25 Tribal Management Grant for a maximum federal award of \$300,000.00 (Three Hundred Thousand Dollars and 00/100) with no tribal match.



**BE IT FURTHER ENACTED** by the Council that this Bill be cited as an acknowledgement that the Chief of the Nation, or his designee, is authorized to prepare, execute, deliver and file any and all agreements, certificates, instruments and documents, in such form and with such terms and provisions as the Chief of the Nation, or his designee, may approve, and to take such other action as he, she or they may deem proper or appropriate, to carry out the intent and purposes of the foregoing enactments.
